Prof. Bertalanffy has recommended, that you receive clinical treatment in the International Neuroscience Institute.

Concerning Corona our current rules are the following:

Our patients and their accompanying persons have to send us a negative Covis-19-test result that isn't older than 3 days before the flight to Germany.

The total costs for your hospital stay (app. 14 days), diagnostic, surgery and necessary medical examinations will amount to approximately

This amount must be deposited in our bank account prior to admission. After the payment we will arrange an Admission date for you.

Should the costs exceed the initially estimated amount during the treatment, the INI reserves to provide appropriate additional amounts of deposit.

To avoid any problems we would kindly ask you to send us the proof of payment via mail or fax.

We will always need the IBAN number as well as the BIC/SWIFT-Code of your bank for the reason of German money laundering law regulations as well as the reporting requirement in foreign trade. In case that a fluent communication neither in German nor in English can be guaranteed by the patient himself, we would ask you to organize yourself a private patient coordinator (such as a translator), to support the patient during his admission and further hospital stay.

Costs and services of a private patient coordinator (such as translators) are not included in the mentioned deposit. All patient support service matters have to be arranged between the patient and the private patient coordinator themselves.

Please note, that the INI as a private institution is not working together with any international insurance companies, as well as we do not accept the treatment form E112.

If there is any remaining amount of your deposit this would, of course, be refunded to you with the final invoice <u>3 months</u> after hospital discharge. For this purpose and further correspondence, please give us your exact mailing address and your banking details. The hospital is only obliged to prepare a final invoice, after the requested amount of deposit or deposits have been paid completely. This includes additional requested amounts during the treatment.

Accompanying persons can only be accommodated in the patients' rooms, if it is medically necessary.

The costs for accompanying persons (room and board) are <u>not</u> covered by the deposit. Kindly note that accompanying persons beneath the age of 18 cannot be accommodated in the hospital.

We asked you for your understanding that a private room can never be guaranteed.

Due to organizational reasons it may be necessary to share a room with another patient during your hospital stay.

All accommodation costs for accompanying persons must be paid for at the time of departure. Payment can be effected in cash or by credit card. In order to guarantee a smooth transaction of the payment please inform your bank in order to be able to exceed your daily credit limit.
